

## **HOSTEL MONITORING COMMITTEE VISITATION REPORT**

**Date of Report:** 01 January 2026

**Date of Inspection:** 31 December 2025

**Time of Inspection:** After 7:15 PM

**Place:** Hostel, SDACH, Sector-46B, Chandigarh

An inspection visit of the hostel premises was conducted by the **Hostel Monitoring Committee** on **31-12-2025 after 7:15 PM** as part of routine monitoring and to address concerns raised by hostel residents.

### **Observations and Complaints Raised by Students**

#### **1. Behavioural Aspect:**

It was reported that proper senior-junior understanding, mutual respect, and cordial behaviour were not being adequately maintained among students.

#### **2. Cleanliness and Hygiene:**

- Students were observed to be keeping Dirty dishes inside their rooms for prolonged periods.
- Leftover food was being disposed of improperly at wash stations, leading to blockage of washroom sinks.
- At times, sanitary pads were not disposed of in designated dustbins, resulting in unhygienic conditions.

#### **3. Washing Machine Facility:**

Students expressed concern that the clothes washing facility is time-consuming, and in certain instances, washing cycles take **3-4 days**, causing inconvenience and prolonged waiting.

#### **4. Hostel Mess (Food Quality):**

- Chapatis were reported to be prepared using maida mixed with wheat flour, with excessive atta powder remaining after cooking and a rubbery texture while eating.
  - Daal was found to be excessively oily, spicy, and watery.
  - Overall taste and quality of food were reported as not up to the expected standard.

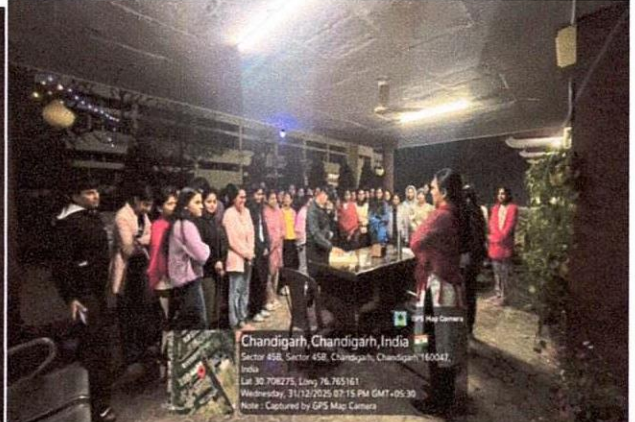
### **Action Taken / Discussion and Resolution**

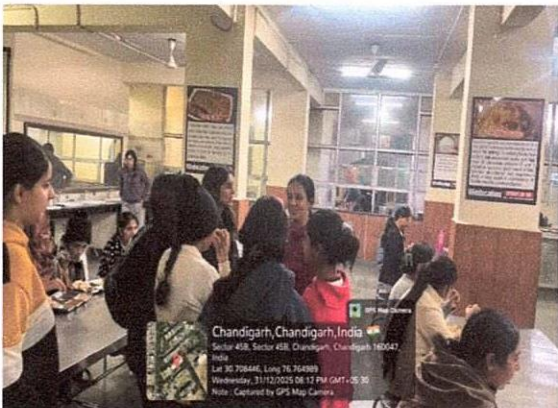
- The issues were discussed in detail with the students during the inspection and were subsequently brought to the notice of the **Hostel Managing Authority**.

- **Strict instructions and warnings** were issued to students regarding behavioural discipline, maintenance of cleanliness, and adherence to hygiene practices within the hostel premises.
- The matters related to the **washing machine facility** and **food quality in the hostel mess** were discussed with the concerned authorities, and suitable corrective measures were assured.

## Conclusion

After due discussion with students and hostel authorities, the inspection was concluded with necessary instructions and resolutions communicated to all concerned.
