Agenda Items:

1. Strengthening Awareness Campaigns

- o Proposals were made to enhance awareness campaigns targeting both new and returning students, emphasizing the legal consequences of ragging and the importance of maintaining respect and dignity on campus.
- O Discussion included utilizing online platforms, social media, and student ambassadors to amplify the message.
- O Action Item: The anti-ragging campaign will be launched online before the beginning of the semester, including video tutorials and interactive webinars with students. Coordination with student leaders will be initiated for better outreach.

2. Enhancement of Reporting Mechanisms

- o The committee discussed the effectiveness of the current reporting mechanisms. While students were aware of the available channels, some concerns were raised about confidentiality and fear of retaliation.
- O Action Item: It was agreed that a confidential and anonymous reporting system will be set up on the institution's website, and a hotline will be introduced. The committee will also work on raising awareness of these channels.

- o The committee emphasized the need for faculty and staff to play a proactive role in identifying and addressing ragging behaviour.
- o It was suggested that workshops and training sessions for faculty be conducted to help them recognize early signs of ragging and intervene appropriately.
- o Action Item: A mandatory faculty training session on anti-ragging will be scheduled for the upcoming semester. A follow-up plan will also be developed to assess its impact.

4. Collaboration with External Authorities

- o The committee discussed opportunities for collaboration with local law enforcement and other educational institutions to exchange best practices and ensure a coordinated response to ragging.
- o Action Item: The committee will reach out to neighbouring institutions for a shared anti-ragging workshop. They will also liaise with local police to establish a rapid response system for incidents of ragging.
